WESTERN MICHIGAN CENTER FOR ARTS & TECHNOLOGY (WMCAT):
PROVIDING SERVICES SINCE 2005, THIS YEAR WMCAT PROVIDED 265 HIGH SCHOOL YOUTH AFTERSCHOOL ART-BASED PROGRAMMING; THE AVERAGE NUMBER OF CONTACT HOURS PER STUDENT WAS 54. IT ALSO EXPANDED ITS COURSE OFFERINGS AND ADDED A STUDENT SERVICES MANAGER POSITION TO HELP ENSURE SENIORS ARE ON TRACK TO GRADUATE FROM HIGH SCHOOL.

COLUMBUS:

DURING THIS YEAR, THE FEASIBILITY STUDY FOR COLUMBUS WAS COMPLETED. IN IT, NCAT RECOMMENDED TO COMMUNITY LEADERS THE ESTABLISHMENT OF SEVERAL YOUTH AND ADULT PROGRAMS THAT GREW OUT OF NEEDS AND INTERESTS INDICATED BY NCAT'S RESEARCH.

CULTIVATION:

THIS STAGE INVOLVES NCAT STAFF EXPLAINING IN DETAIL TO COMMUNITY MEMBERS AND LEADERS THE MBC MODEL AND FEASIBILITY PHASE; AT THE SAME TIME, NCAT STAFF LEARN MORE ABOUT THE NEEDS AND INTERESTS OF CITIES IN ORDER TO ASSESS IF SUCH LOCATIONS HAVE WHAT NCAT HAS LEARNED ARE KEY ATTRIBUTES AND COMMITTED LEADERS, TO MOVE THROUGH A REPLICATION PROJECT. CULTIVATION PHASE ACTIVITY INDICATES THAT THESE SIX LOCATIONS, BOTH US AND INTERNATIONAL, ARE VERY INTERESTED IN PURSUING THE FEASIBILITY PROCESS WITH NCAT: AUSTIN, BOSTON, CHICAGO, RICHMOND AND VANCOUVER, BRITISH COLUMBIA AND NORTHERN ISRAEL. MANY OTHER CITIES HAD CONTACT WITH NCAT DURING THIS PERIOD.
